### Terms & Conditions for Tendering

- The tender form & BOQ is available on GDA website & can be downloaded from GDA website. The bids shall be submitted through courier on or before the fix date/Time.
- The bidder shall submit the bid with requisite documents through courier including 2% of bid security of the estimated cost in the shape of call deposit (Original in seal envelop before closing date & time)
- In case of bid/rate quoted by the bidder more than 10% below engineer estimate, the additional bid security shall be sort from the successful bidder only to extent of bid more than 10% below the engineer estimate in the form of percentage. The amount of additional bid security shall be equal to impact of financial difference occurring in the quoted rates beyond 10% below engineer estimate.
- All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, Established under the Khyber Pakhtunkhwa finance act 2013 (Khyber Pakhtunkhwa act No. XXI of 2013) , for works, consulting and non-consulting services as listed in schedule-II of the act ibid
- Tenders shall be opened in the presence of bid opening committee & bidders or their authorized representative who care to be present. In case of any unforeseen reasons, public holidays, on rest or force majeure on the bid submissions/opening date, the tender shall be opened on the next working day at the same place and time
- The bid must be duly signed by the original enlisted contractor/Firm otherwise the bid will be treated as non-responsive/defective.
- The validity of the tender/bid shall be 90(Ninety) days.
- All federal and provincial duties/stamp duties/taxes including sales tax will be recoverable as per directives of the government issued from time to time.
- Call deposit of scheduled banks shall be acceptable. Pay order/Cheque/Demand draft will not be acceptable at any cost
- If any documents submitted along with bid documents found false/Bogus the registration of the contractors/ Firms shall be stands cancelled/ blacklisted.
- Any disfiguring/overwriting/manipulation in the tender shall be liable to rejection.
- Only the first two figures after decimal of the rate will be considered for evaluation of the bid.
- Incomplete, conditional and bid without 2% of earnest money or without additional security (if involved) shall be considered as non-responsive
- Copy of enlistment (renewal 2020-21) CNIC, NTN, KPPRA and PEC registration in relevant category must be attached with the bid.
- Bid security of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> lowest bidders shall be retained & will not be returned till the approval of bid from competent Authority.
