Terms & Conditions for Tendering

1. The tender form & BOQ is available on GDA website & can be downloaded from GDA website. The bids shall be submitted through courier on or before the fix date/Time. The bid without tender form will not be acceptable.
2. The bidder shall submit the bid with all requisite documents through courier including 2% of bid security of the estimated cost in the shape of call deposit (Original in seal envelop before closing date & time)
3. In case of bid/rate quoted by the bidder more than 10% below estimate, the additional bid security shall be sort from the successful bidder only to extent of bid more than 10% below the estimate in the form of percentage. The amount of additional bid security shall be equal to impact of financial difference occurring in the quoted rates beyond 10% below estimate.
4. Tenders shall be opened in the presence of bidders or their authorized representatives and bid opening committee who care to be present. In case of any unforeseen reasons, public holidays, on rest or force majeure on the bid submissions/opening date, the tender shall be opened on the next working day at the same place and time.
5. The validity of the tender/bid shall be 90(Ninety) days.
6. All federal and provincial duties/stamp duties/taxes including sales tax will be recoverable as per directives of the government issued from time to time.
7. Call deposit of scheduled banks shall be acceptable. Pay order/Cheque/Demand draft will not be acceptable at any cost
8. If any documents submitted along with bid documents found false/Bogus the registration of the contractors/ Firms shall be stands cancelled/ blacklisted.
9. Any disfiguring/overwriting/manipulation in the tender shall be liable to rejection.
10. Only the first two figures after decimal of the rate will be considered for evaluation of the bid.
11. Incomplete, conditional and bid without 2% of earnest money or without additional security (if involved) shall be considered as non-responsive
12. Bid security of 1st, 2nd and 3rd lowest bidders shall be retained & will not be returned till the approval of bid from competent Authority.
