Terms & Conditions for Tendering

1. The bidder must be provide registration certificate with Electric Inspector of Government of Khyber Pakhtunkhwa.
2. The bidder shall submit the bid with all requisite documents through courier including 2% of bid money as a security in the shape of call deposit
3. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, Established under the Khyber Pakhtunkhwa finance act 2013 (Khyber Pakhtunkhwa act No. XXI of 2013) , for works, consulting and non-consulting services as listed in schedule-II of the act ibid
4. Sealed tenders shall be opened in the presence of bidders or their authorized representatives and bid opening committee.
5. The bid must be duly signed by the suppliers, contractor, Firm otherwise the bid will be treated as non-responsive/defective.
6. The validity of the tender's, bid's shall be 90(Ninety) days.
7. All type of federal and provincial taxes i.e stamp duties, sales tax will be deducted from the suppliers, firms as per directives of the Government which will be issued from time to time.
8. Call deposit of scheduled banks shall be acceptable. Pay order, Cheque, Demand draft will not be acceptable at any cost.
9. If any documents submitted along with bid documents found false, Bogus the bid/registration of the contractors, Firms shall be stands cancelled.
10. Any disfiguring, overwriting, manipulation in the tender shall be liable to rejection.
11. Only the first two figures after decimal of the rate will be considered for evaluation of the bid.
12. Incomplete, conditional bid without 2% of earnest money shall be considered as non-responsive
13. Copy of current financial year registration, enlistment with CNIC, NTN, KPPRA and PEC registration in relevant category must be attached with the bid otherwise the bid liable to rejection.
14. Call deposit of 1st , 2nd and 3rd lowest bidders shall be retained & will not be returned till the approval of lowest bidder from the competent Authority.
