### **INSTRUCTIONS TO BIDDERS**

- The bid should accompanied the following documents duly attested:
  - Copy of enlistment by the Provincial Enlistment Committee KPK with renewal 2023-24.
  - Enlistment Order of Galiyat Development Authority Abbottabad(photocopy)
  - Renewal of registration with GDA for the year 2023-24.
  - National Identity Card (CNIC Photocopy)
  - Copy of the valid registration of Pakistan Engineering Council.
  - Form H of the Company /Firm.
  - Income Tax/NTN Certificates.
  - Any other document to support the bid.
- Incomplete/Conditional bids and bids received after closing date shall not be entertained. Bids must be signed by authorized persons only.
- 2% bid security in shape of call deposit (in Original) issued by the schedule banks only should be enclosed along with bidding documents.
- Bidding entry fee for Rs.0.03% (non-refundable) as per KPPRA notification dated: 05/4/2021 in shape of pay order in the name of Director General, GDA must be attached with the bid.
- The contractors quoting their bids up to a limit of 10% below Engineer Estimate shall submit bid security to the extent of 2%of Engineer Estimate only.
- The contractor quoting their bids more than 10% below up to 20% below on Engineer Estimate shall submit along with their bids 8% Additional Security of Engineer Estimated Cost in addition to 2% bid security. If the bid is not accompanied with the required amount of Additional Security then it will

- be considered as non-responsive and the 2% bid security shall be forfeited in favor of Govt. and the 2<sup>nd</sup> lowest bidder and soon will be considered accordingly.
7. Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer Estimated Cost equal to the differential amount of submitted bid and Engineer Estimate along with detail rate analysis. In case of more than 20% below bids if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security then the said bid shall be considered as non-responsive. All the securities submitted along with such non responsive bid shall be forfeited in favor of Govt. and the 2<sup>nd</sup> lowest bidder and soon will be considered accordingly.
  8. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the **Head** of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
  9. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids are may advertise procurement opportunity afresh.
  10. The additional security shall be released to the contractor in (04) Four installments i.e. 1<sup>st</sup> Installment of 25% to be released upon completion of 25% of the project 2<sup>nd</sup> Installment of 25% to be released upon completion of 50% of the project 3<sup>rd</sup> Installment of 25% to be released upon completion of 75% of the project & the 4<sup>th</sup> Installment of 25% to be released after 100% completion of the project.
  11. Any bidder who provides incorrect information, fake documents shall be disqualified.
  12. Bids will be valid for Ninety (90) days.
  13. Successful Bidder should Sign the agreement with the department within stipulated time after acceptance of bid.
  14. If the evaluated bid costs of two or more than two bidders are same then the successful bid will be declared through draw.
  15. Bid security of the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> lowest bidder for the specific work will be retained by the Department till the approval of bids.
  16. The bidder must be enlisted with the Khyber Pakhtunkhwa Revenue Authority as per KPPRA Rules.
  17. Pay Order in the case of 2% bid & 8% Additional Security will not be acceptable as per Notification by KPPRA vide No.KPPRA/M&E/Estt:/1-12/2017-18, dated:05/04/2018.
  18. All Government taxes will be applicable as per prevailing rules.
