No. PA/Khyber Pakhtunkhwa/Bills-91/2020/6249.— The Galiyat Development Authority (Amendment) Bill, 2020 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 24th February, 2020 and assented to by the Governor of the Khyber Pakhtunkhwa on 2nd March, 2020 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE GALIYAT DEVELOPMENT AUTHORITY (AMENDMENT) ACT, 2020. (KHYBER PAKHTUNKHWA ACT NO. XVII OF 2020)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 4th March, 2020).

AN ACT

to amend the Galiyat Development Authority Act, 2016.

WHEREAS it is expedient to amend the Galiyat Development Authority Act, 2016 (Khyber Pakhtunkhwa Act No. XII of 2016), for the purposes hereinafter appearing;

It is hereby enacted as follows:

- 1. Short title and commencement.---(1) This Act may be called the Galiyat Development Authority (Amendment) Act, 2020.
 - (2) It shall come into force at once.
- 2. Amendment of the Preamble of Khyber Pakhtunkhwa Act No. XII of 2016.—In the Galiyat Development Authority Act, 2016 (Khyber Pakhtunkhwa Act No. XII of 2016), hereinafter referred to as the said Act, in the preamble, after second paragraph, the following new paragraph shall be added, namely:

"AND WHEREAS, Government wants to promote tourism in the Khyber Pakhtunkhwa Province particularly in Galiyat area;".

- 3. Amendment of section 2 of Khyber Pakhtunkhwa Act No. XII of 2016.---In the said Act, in section 2,-
 - (a) after the existing clause (a), the following new clause shall be inserted, namely:
 - "(a-i) "Authorized Officer" means an officer of the Authority, authorized under section 28 of this Act;";
 - (b) after clause (c), the following new clause shall be inserted, namely:
 - "(c-i) "executive authority" means all administrative, financial and disciplinary powers of the Authority;";
 - (c) after clause (g), the following new clause shall be inserted, namely:
 - "(g-i) "littering" means all waste material, refuse, cans, bottles, garbage, trash, debris, dead animals or other discarded materials of every kind and description which are hazardous to environment;";
 - (d) in clause (m), the word "and", appearing at the end, shall be deleted;
 - (e) in clause (n), the full-stop appearing at the end, shall be replaced with semi-colon and after the semi-colon, the word "and" shall be added; and
 - (f) after clause (n), as so amended, the following new clause shall be added, namely:
 - "(o) "tourism" means a collection of activities, services and industries which deliver a travel experience comprising transportation, accommodation, eating and drinking establishments, retail shops, entertainment business and other hospitality services, provided for individuals or groups, travelling away from home.".
- 4. Amendment of section 4 of Khyber Pakhtunkhwa Act No. XII of 2016.---In the said Act, in section 4,-
 - (a) for sub-section (1), the following shall be substituted, namely:
 - "(1) The Authority shall consist of eleven (11) members, to be appointed and notified by Government."; and
 - (b) after sub-section (1), as so amended, the following new sub-section shall be inserted, namely:

- "(1A) The members shall include-
 - (a) five (5) members from private sector, one of whom shall be from tourism sector, with no conflict of interest;
 - (b) two (02) local Members of the Provincial Assembly of the Khyber Pakhtunkhwa, from the Galiyat area; and
 - (c) four (04) members from Government sector.".
- 5. Amendment of section 6 of Khyber Pakhtunkhwa Act No. XII of 2016.---In the said Act, in section 6,-
 - (a) in sub-section (4),-
 - (i) for clause (a), the following shall be substituted, namely:
 - prepare, manage and implement through line departments and "(a) any other Government Agency, feasible means, schemes of education, health, agriculture and industry, forest conservation and development, preservation of wildlife, promotion of tourism through better quality tourism service facilitate private investment, conduct surveys and prepare a strategy to further strengthen existing tourism, develop new tourism products focusing on family, youth, corporate segments, develop tourism web portal to provide one step solution and facilitate tourists for getting up-dated information and booking of hotels, transport and tour packages, project touristic attraction through print and electronic media at the relevant place, improvement of water supply, land slide management, development of irrigation facilities, development of means of communication, construction and development of housing, sewerage, drainage, environmental improvement and slum clearance or any other thing pertaining to the purposes of this Act;";
 - (ii) for clause (c), the following shall be substituted, namely:
 - "(c) sell, lease, exchange, transfer, mortgage, put under lien or encumbrances, allot, hire, cancel, restore, regularize or otherwise dispose of or deal in any property vested in or entrusted to the Authority, in such a manner as may be prescribed;";

- (iii) in clause (n), after the word and comma "taxes,", the words and commas "fee, charges," shall be inserted;
- (iv) after clause (o), the following new clause shall be inserted, namely:
 - "(o-i) make policies, from time to time, for carrying out the purposes of this Act;"; and
- (b) after sub-section (6), the following new sub-section shall be added, namely:
 - "(7) The Authority shall declare emergency, for unforeseen events, caused by nature or man-made.".
- 6. Amendment of section 7 of Khyber Pakhtunkhwa Act No. XII of 2016.--- In the said Act, in section 7, for sub-section (1), the following shall be substituted, namely:
 - "(1) Notwithstanding anything contained in any other law for the time being in force, the Authority shall collect fees or user charges for the services it provides or facilities it extends to the public, including fee or charges on account of conservancy, maintenance of public parks, green belts and green areas, within the Galiyat areas.".
- 7. Substitution of section 9 of Khyber Pakhtunkhwa Act No. XII of 2016.— In the said Act, for section 9, the following shall be substituted, namely:
 - "9. Constitution of the committees.—The Authority may constitute financial committee, technical committee, tourism committee, departmental accounts committee, departmental procurement committee, consultant committee, auction committee, departmental working approval committee, dispute resolution committee, advisory committee or any other committee, as it may deem necessary, to be chaired by the Director General, for carrying out of the purposes of this Act and such committees shall exercise such powers and perform such functions as may be delegated or assigned to them by the Authority."
- 8. Amendment of section 10 of Khyber Pakhtunkhwa Act No. XII of 2016.--- In the said Act, in section 10,-
 - (a) for sub-section (1), the following shall be substituted, namely:
 - "(1) Government may post a Government Officer, not below the rank of BPS-19, to act as Director General of the Authority for a term not exceeding three (03) years."; and
 - after sub-section (5), the following new sub-section shall be added, namely:

- "(6) Save as otherwise provided the executive authority shall vest in and be exercised by the Director General.".
- 9. Amendment of section 11 of the Khyber Pakhtunkhwa Act No. XII of 2016.---In the said Act, in section 11, sub-section (2) shall be deleted.
- 10. Substitution of section 21 of Khyber Pakhtunkhwa Act No. XII of 2016.---In the said Act, for section 21, the following shall be substituted, namely:
 - "21. Budget and accounts.---(1) The Director General shall submit annual budget estimates and working plan to the Authority and the Authority may modify the said estimate or working plan to the extent of Authority's fund or grants as it may consider necessary.
 - (2) The accounts of the receipts and expenditure of the Authority shall be kept in such form as may be prescribed by regulations.
 - (3) The Director General shall within three (03) months of the close of each financial year, place before the Authority, the annual statement of accounts and audited balance sheet, profit and loss account and the auditor's report, for the preceding financial year."
- 11. Substitution of section 23 of Khyber Pakhtunkhwa Act No. XII of 2016.—In the said Act, for section 23, the following shall be substituted namely:
 - "23. Annual report.---The Director General, with the approval of Authority, shall, within four (04) months after the end of every financial year, submit an annual report to the Government on the conduct of its affairs for that year.".
- 12. Substitution of section 28 of Khyber Pakhtunkhwa Act No. XII of 2016.---In the said Act, for section 28, the following shall be substituted, namely:
 - **"28.** Imposition of fine---(1) Where an officer of the Authority, authorized by the Director General, is of the opinion that any person, who contravenes the provisions of this Act, relating to offences as specified in the **Schedule**, appended to this Act, shall charge the accused by issuing a ticket, in the form as specified by Authority, for payment of fine, as provided in the Schedule.
 - (2) In case of failure, to pay the fine under sub-section (1), within the specified time, and any other kind of outstanding dues, shall be recovered as arrears of land revenue under the Land Revenue Act, 1967 (Act No. XVII of 1967).".
- 13. Insertion of new section in the Khyber Pakhtunkhwa Act No. XII of 2016.—In the said Act, after section 28, as so amended, the following new section shall be inserted, namely:

- Violation of agreements --- (1) Whoever violates or contravenes the terms and conditions of lease agreement, rent agreement, sale agreement or any other agreement or default in payment of lease money, levy, taxes etc, or makes other violations of rules and regulations, for the first and second time, shall be liable to fine which may extend to rupees one (01) million, and its repetition for thrice within the time as specified in the notice to be served shall lead to the cancellation of agreement.".
- Substitution of section 30 of the Khyber Pakhtunkhwa Act No. XII of 2016 .--- In the said Act, for section 30, the following shall be substituted, namely:
 - Offences to be cognizable and non-bailable .--- The offences, mentioned under this Act shall be cognizable and non-bailable and the Court of District and Session Judge shall take cognizance of offences punishable under this Act upon a complaint by an officer of the Authority, authorized by the Director General, in this behalf.".
- Substitution of section 32 of Khyber Pakhtunkhwa Act No. XII of 2016 .-- In the 15. said Act, for section 32, the following shall be substituted, namely:
 - "32. Appeals against the orders of the Authority.--(1) Any person, aggrieved by any decision or order of the Director-General or any other officer of the Authority, acting under delegated powers of the Authority, may, within thirty days (30) of the receipt of such decision or order, appeal to the Chief Secretary, Khyber Pakhtunkhwa, to decide the issue within a period of one hundred and twenty (120) days.
 - The Chief Secretary, Khyber Pakhtunkhwa, while exercising the powers under sub-section (1), may delegate his power to an officer, not below the rank of BPS-20, to hear and dispose of the appeal.
 - The decision made in the appeal shall be final.".
- Amendment of section 33 of Khyber Pakhtunkhwa Act No. XII of 2016.---In the said Act, in section 33, for the word "manger", the word "manager" shall be substituted.
- Addition of the Schedule to the Khyber Pakhtunkhwa Act No. XII of 2016 .--In the said Act, after section 41, the following Schedule, at the end, shall be added, namely:
