- 2. The bid should accompanied the following documents duly attested:
  - a. Copy of enlistment by the Provincial Enlistment Committee KPK with renewal 2024-25.
  - b. Enlistment Certificate of Galiyat Development Authority Abbottabad(photocopy). 2024-25
  - c. National Identity Card (CNIC Photocopy)
  - d. Copy of the valid registration of Pakistan Engineering Council Valid Upto June 2025.
  - e. Form H of the Company /Firm.
  - f. Income Tax/NTN Certificates.
  - g. Any other document to support the bid.
  - h. Bid documents and instruction to bidders can be downloaded from Galiyat Development Authority website (<a href="www.gda.gkp.pk">www.gda.gkp.pk</a>) & KPPRA website (<a href="www.kppra.gov.pk">www.kppra.gov.pk</a>) before the submission date/time.

- 3. Incomplete/Conditional bids and bids received after closing date and time shall not be entertained. Bids must be signed by authorized persons only.
- 4. 2% bid security in shape of call deposit in favor of DG GDA Abbottabad (in Original) issued by the schedule banks only should be enclosed along with bidding documents otherwise the bid will be considered as non-responsive. If a contractor quotes his bid more than 10% Below he is bound to enclose additional CDR amounting to 8% of estimated cost of Engineer Estimate in favor of DG GDA Abbottabad.
- 5. Bidding entry fee of Rs.0.03% (non-refundable) as per KPPRA notification dated: 05/4/2021 in shape of CDR in the name of Director General, GDA must be attached with the bid.
- 6. Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer Estimated Cost equal to the differential amount of submitted bid and Engineer Estimate along with detail rate analysis. In case of more than 20% below bids if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security then the said bid shall be considered as non-responsive. All the securities submitted along with such non responsive bid shall be forfeited in favor of Govt. and the 2<sup>nd</sup> lowest bidder and soon will be considered accordingly.
- 7. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the **Head** of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
- 8. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids are may advertise procurement opportunity afresh.
- 9. The additional security shall be released to the contractor in (04) Four installments i.e. 1" Installment of 25% to be released upon completion of 25% of the project 2"Installment of 25% to be released upon completion of 50% of the project 3<sup>rd</sup> Installment of 25% to be released upon completion of 75% of the project & the 4<sup>th</sup> Installment of 25% to be released after 100% completion of the project.
- 10. Any bidder who provides incorrect information, fake documents shall be debar, disqualified & blacklisted.
- 11. Bids will be valid for Ninety (90) days.
- 12. Bid must reach this office before closing time of submission of Bids through registered Courier.
- 13. Successful Bidder Should Sign the agreement with the department with in stipulated time after acceptance of bid.
